



1965 SHELBY COBRA REPLIC A ROADSTER CHARITABLE RAFFLE benefitting The Martin House Children's Advocacy Center

OFFICIAL RULES

1. **SPONSOR:** The Martin House Children's Advocacy Center (TMHCAC), 606 W. Garfield Dr., Longview, TX 75602 (hereinafter referred to as "Sponsor").
2. **ELIGIBILITY:** Entry in TMHCAC Charitable Raffle (the "Raffle") is open to individuals 18 years of age or older at the time of purchase of the raffle ticket(s). The Raffle is void where prohibited. Current TMHCAC employees and members of TMHCAC's Board of Directors and/or their spouses or legal domestic partners are not eligible to win.
3. **HOW TO ENTER:** Raffle tickets are \$100 each. To enter the Raffle, purchase a raffle ticket no later than 11:59 p.m. central time on April 14, 2025. Sale of raffle tickets will commence on July 25, 2024. There is no limit to the number of raffle tickets a person can purchase. Odds of winning depends on the number of raffle tickets sold.
4. **WINNER SELECTION:** Five (5) raffle ticket perforated stubs will be drawn at random from the drawing machine and listed in numerical order of being drawn. The first ticket stub drawn is the first potential prize winner, with the others being alternate winners, in the order in which the stubs were drawn. The winner selection will be made by a designated representative of Sponsor on April 15, 2025 at approximately 8:00 p.m. central time. Purchasers of the raffle tickets need not be present to win. However, the raffle ticket perforated stub must contain the name, phone number, address, and email address of the raffle ticket purchaser in order for Sponsor to notify the purchaser of the results of the drawing. The raffle ticket with the one unique number matching the number of the raffle ticket perforated stub drawn from the drawing machine shall be the only valid proof of the winning ticket and the only valid receipt for claiming the prize.
5. **ONE (1) RAFFLE PRIZE:** A custom burgundy 1965 Shelby Cobra authentic replica roadster, built by Backdraft Racing, with a manual 5-speed 427 Iconic Cobra engine (driven 700 miles) and tan diamond tuck interior leather appraised at \$87,000-\$94,000.
6. **ONE PRIZE WINNER:** Prize Winner must claim the Raffle Prize in person and accept possession of Raffle Prize at The Martin House CAC at 606 W. Garfield Dr., Longview, TX 75602 within 30 days of notification of the results of the drawing. The value of the Raffle Prize is not redeemable for cash and the Raffle Prize is non-transferable. Prize Winner will be exclusively and solely responsible for all applicable taxes, tags, title, insurance, and registration costs, as well as any other costs/expenses associated with acceptance and use of the vehicle. All prize details are at Sponsor's sole discretion.
7. **CLAIMING PRIZE:** Sponsor will notify the potential prize winner by email, mail, or phone within two (2) business days following the date of the drawing. The potential prize winner is required to complete, execute and return Disclaimer regarding eligibility as well as a W9 form and any other required documents prior to or at the time of claiming the Raffle Prize. The winner will be required to provide valid identification in the form of an official government-issued photo identification and his or her Social Security number and appropriate tax documentation for tax reporting purposes. The prize will not be awarded until Prize Winner signs and returns the eligibility Disclaimer and provides any other required documents and until these documents have been formally verified. If Prize Winner fails to claim the Raffle Prize at The Martin House CAC at 606 W.

Garfield Dr., Longview, TX, comply with the Official Rules, and submit required documentation within 30 days of notification of the results of the drawing, disqualification and prize forfeiture will result and the next selected alternate from the drawing will be deemed the potential prize winner. This process will continue until the earlier of: (a) the prize winner is selected; or (b) all alternate winners have been exhausted. Subject to verification of eligibility, the potential prize winner will be declared the official winner of the charitable raffle.

8. **PUBLICITY CONSENT:** Acceptance of the Raffle Prize constitutes Prize Winner's consent to the use by Sponsor of Prize Winner's name, photograph, likeness, statements, testimonials, and/or text for advertising, promotional or any other purposes in any medium throughout the world in perpetuity without additional compensation, notification, or consent, unless prohibited by law.
9. **GENERAL CONDITIONS AND INDEMNITY AND RELEASE:** By purchasing a raffle ticket, purchaser agrees to
 - a. indemnify, release and hold harmless the Sponsor and associated parties from any and all losses, damages, rights, claims and actions of any kind in connection with the Raffle, including without limitation property damages, personal injury and/or death arising out of participating in this Raffle and acceptance and use of the Prize (including any injury or harm related thereto) and/or claims based on publicity rights, defamation or invasion of privacy, copyright infringement, trademark infringement and/or any other intellectual property rights;
 - b. be fully and completely bound by all applicable laws, these charitable raffle rules, instructions, conditions and final decisions of Sponsor, and all procedures established by Sponsor for the conduct of the charitable raffle.
10. **DISQUALIFICATION:** Sponsor reserves the right at its sole discretion to disqualify any individual who:
 - a. tampers or attempts to tamper with the operation of the Charitable Raffle;
 - b. violates these Official Rules.
11. **RELEASE:** Sponsor is not responsible for lost or stolen raffle tickets; delayed, misdirected, or undelivered emails, notifications, mail, or other communications of any kind; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Raffle, including, without limitation, errors or difficulties which may occur in connection with the administration of the Raffle, the announcement of the Prize Winner, or in any Raffle-related materials. Sponsor is also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Raffle.
12. **USE OF DATA:** Sponsor will collect personal data about raffle ticket purchasers from information provided by purchasers on their Raffle tickets. This data will be used solely for Sponsor's purposes and will not be disclosed or sold to other organizations.
